## ARTICLES OF INCORPORATION

OF

## SIGMA PHI OMEGA NATIONAL HONOR SOCIETY

We, the undersigned natural persons of age 21 years or more, acting as incorporators of a corporation under the Nonprofit Corporation Act (D.C. Code, 1981 edition, Title 29, Chapter 5), adopt the following Articles of Incorporation.

FIRST: The name of the corporation is Sigma Phi Omega National Honor Society.

SECOND: The period of duration is perpetual.

THIRD: The purposes for which the corporation is

organized are:

- (1) To promote scholarship and professionalism in the field of gerontology and aging studies;
- (2) To recognize exemplary attainment in gerontology and aging studies;
- (3) To disseminate to the public information on the field of aging;
- (4) To foster community service and other charitable activities directed toward older persons;
- (5) To do other things necessary or appropriate to the

accomplishment of any of the objects or purposes for which this corporation is formed and generally to exercise all of its powers as are now or may hereafter be conferred by law upon nonprofit

Notwithstanding any other provisions of these Articles, the corporation shall not carryon any other activities not permitted to be carried on by:

corporations under the laws of the District of Columbia.

(a) a corporation exempt from federal income

tax under Section 501(c)(3) of the Internal Revenue Code of 1954,

as amended (or any corresponding provision of any future United

States Internal Revenue Code), or (b) a corporation to which

contributions are deductible under section 170(c)(2) of the

Internal Revenue Code of 1954, as amended (or the corresponding

provision of any future united states Internal Revenue Code).

FOURTH: The corporation shall have members. Each member

shall be affiliated with a local chapter and each chapter shall

be entitled to at least one vote. The number of votes allowed

per chapter shall be provided in the bylaws.

FIFTH: There shall be a Board of Directors composed of no less than seven nor more than 15 members. The manner of the appointment and removal of directors shall be provided in the Bylaw of the corporation.

SIXTH: The Board of Directors shall have supervision, control and direction of the affairs of the corporation, determine its

policies within the limit of these Articles and the

Bylaws of the corporation, actively prosecute its objectives, and
have discretion in the distribution of its funds. It may adopt
such rules and regulations for the conduct of its business as
shall be deemed advisable and may, in the execution of its
powers, appoint such agents as it may consider necessary.

All of the property of this corporation, and accumulations thereof, shall be held and administered to effectuate its nonprofit purposes. Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all the liabilities of the corporation, dispose of all of the assets of the corporation to such organization or organizations as the Board of Directors shall select, which are organized and operated exclusively for charitable, scientific or educational purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c) of the Internal Revenue Code of 1954, as amended (or the corresponding provision of any future United States Internal Revenue Code). SEVENTH: The address, including street, number and zip code, of the initial registered office of the corporation is 1001 Connecticut Avenue, N.W. Suite 410, Washington, D.C. 20036, and the name of the registered agent at such address is Elizabeth B. Douglass.
